RESOLUTION AUTHORIZING AND THE APPOINTMENT OF THE EMERGENCY MANAGEMENT COORDINATOR AND THE DEPUTY EMERGENCY MANAGEMENT COORDINATOR

WHEREAS, the mayor desires to appoint an Emergency Management Coordinator and also desires to appoint a Deputy emergency Management Coordinator. And;

WHEREAS Gary Vanmeter Sr is qualified to serve as the Emergency management Coordinator for the Borough of Shiloh, and;

WHEREAS Donna Vanmeter is qualified to serve as the Deputy Emergency Management Coordinator for the Borough of Shiloh, and;

WHEREAS, the Borough Council is desirous of giving advice and consent to the Mayor's appointments of the Emergency Management Coordinator and Deputy Emergency Management Coordinators.
