CALL TO ORDER

A regular meeting of the Shiloh Borough Council was held on May 1, 2023. Mayor Brad Campbell called the meeting to order a 7:00 pm in the Borough Council Meeting Room, 900 Main Street, Shiloh, New Jersey.

A RESOLUTION AUTHORIZING THE TAX COLLECTOR

AND TREASURER TO REFUND A ONE THOUSAND THREE HUNDRED THIRTY-TWO DOLLAR AND THIRTY-NINE CENTS (\$ 1332.39) OVERPAYMENT

OF ROLLBACK TAXES FOR BLOCK 1 LOT 28.03 KNOWN AS 406 WEST AVENUE.

WHEREAS, the Borough Council of the Borough of Shiloh, County of Cumberland, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Borough of Shiloh for a Resolution authorizing a refund of overpayment of Roll Back Taxes; and

WHEREAS, in the 2021 Tax Year, this property was billed estimated Rollback Taxes which was over estimated creating an overpayment of Property Taxes due; and

WHEREAS, the Tax Collector of the Borough of Shiloh is in receipt of a request by Dominion Title Services/Bridgeton, Inc. for a refund of the Overpayment of \$ 1332.39 to be refunded for Block 1 Lot 28.03; and

WHEREAS, after due deliberation and discussion with the Township Treasurer, and Tax Collector, the Borough Council of the Borough of Shiloh, County of Cumberland has determined that it is appropriate for the Borough of Shiloh to refund the erroneous payment of Roll Back taxes to Dominion Title Services/ Bridgeton, Inc.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Shiloh, County of Cumberland, State of New Jersey, that the Overpayment of real property taxes in the amount of one thousand three hundred thirty-two dollar and thirty-nine cents (\$ 1322.39), shall be refunded to Dominion Title Services/Bridgeton, Inc., 55 E. Commerce Street, Bridgeton, New Jersey 08302; and

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Borough of Shiloh for their records.

A RESOLUTION AUTHORIZING EXECUTION OF A SHARED SERVICES AGREEMENT WITH LAWRENCE TOWNSHIP FOR THE PROVISION OF CERTIFIED RECYCLING PROFESSIONAL SERVICES TO CERTIFY AND SUBMIT THE 2022 RECYCLING TONNAGE REPORT TO THE NJDEP

WHEREAS, the Borough of Shiloh (herein after "Shiloh") among other things, employs a Certified Recycling Professional, and;

WHEREAS, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1, et seq.) (herein after "the Act") provides that local units of government may enter into a contract to provide or receive any service that either local unit participating in the Agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any participating units (N.J.S.A. 40:65-4, and;

WHEREAS, the Borough of Shiloh will prepare the 2022 Township of Lawrence Recycling Tonnage Report, and;

WHEREAS, the Township of Lawrence has requested the services of a Certified Recycling Professional to prepare the 2022 Township of Lawrence's Recycling Tonnage Report and submit the required 2022 Tonnage Report by April 30, 2023, and;

Whereas, Shiloh has the qualified staff to certify the Recycling Tonnage Report and electronically submit it to the NJDEP on behalf of the Township of Lawrence under the terms and conditions set forth in the Shared Services Agreement.

NOW THEREFORE BE IT RESOLVED by the Borough Council of the Borough of Shiloh, County of Cumberland and State of New Jersey as follows:

1. The Borough of Shiloh Mayor and Municipal Clerk are hereby authorized and directed to execute a Shared Services Agreement, a copy of which is attached hereto, with the Township of Lawrence for the Borough of Shiloh's Certified Recycling Professional to prepare, certify and submit the Township of Lawrence's 2022 Recycling Tonnage Report.
